I. Demand Survey on Support Program for Overseas Korean Adoptees

A. Title of the Program:

- **The Support Program for the Future-generation Overseas Korean Adoptees**

B. Duration of the Program:

- 2025. 01. ~ 2025. 12. (January 2025 – December 2025)

C. Purpose of the Program

- To enhance mutual exchange and a sense of solidarity between overseas Korean adoptees through building and promoting networks
- To promote the rights of the future-generation overseas Korean adoptees and to enable them to Successfully settle down in the countries where they are living in
- To establish a sense of Korean identity for overseas Korean adoptees and create ethnic bond

D. Projects in Major Priority

- Projects hosted by the organizations of the overseas Korean adoptees
 - Enhancing mutual exchange and a sense of solidarity through building and promoting networks for overseas Korean adoptees
 - Conferences, workshop, mentoring, or large events by continent/country/region
 - projects related to establishing a sense of Korean identity and creating an ethnic bond for overseas Korean adoptees
 - Interchange activities between (the organizations of) regional Korean community

- Legal support/advice for non-citizens those seeking citizenship for overseas Korean community
- Local conference, seminar, public hearing, campaign, etc. for improving the rights and interests of the overseas Korean adoptees
- Cultural and artistic activities such as exhibitions, performance events in which overseas Korean adoptees participate
- Projects related to collecting and archiving the history overseas Korean adoptees

II. How to apply

- **Use the Online Application system (www.korean.net)**
 - * Please refer to appendix [online user guide] for details
 - * The project proposal(plan) must be specific and clear.
 - * When there are several projects for one organization, need to apply on a case by case

III. Submission Deadline(Korea Standard Time)

- **Submission Deadline for Group: 13.(Fri).December.2024**
 - * Please be aware that all documents must be submitted no later than 13 December
 - *The Diplomatic office will evaluate the documents (9.Dec.(Mon.)-20.Dec.(Fri.))

IV. Selection Criteria and Procedure

A. Selection Criteria

- Both the importance, desirability of a project and the appropriateness of the budget execution plan are considered when supporting an organization

- When there are several projects for one organization, major project will be given priority consideration.
- If an organization have received grant before, the performance of the last project and the faithfulness of the last execution report will be reviewed with the submitted forms

B. Selection Procedure

- 1) The diplomatic office will evaluate the documents
- 2) The OKA committee/board will be held
- 3) OKA will review the documents and decide the amount of the grant
- 4) The grant will be remitted to the diplomatic office

V. Required Documents

**All application materials must be submitted in either English or Korean*

- a) Grant Application Form (Online Form)
- b) Project Proposal Form (Online Form)
- c) Organization Status Report (Online Form)
- d) Budgetary Document of Income & Expenditure for the Grant(Online Form)
*Attachment : Brief History of Organization, Articles of association, copy of corporate registration(if so)
- e) Other documents that the Commissioner of the Overseas Koreans Agency deem necessary(Submission if requested)

*All application materials must be submitted in either English or Korean
